

## Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://digierack.com> and Digierack, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Digierack, LLC include <https://digierack.com>, Digierack. The Digierack website is a Web Design & Hosting Solutions site. By using the Digierack website, you consent to the data practices described in this statement.

### Collection of your Personal Information

Digierack may collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

### Sharing Information with Third Parties

Digierack does not sell, rent or lease its customer lists to third parties.

Digierack may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Digierack, and they are required to maintain the confidentiality of your information.

Digierack may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Digierack or the site; (b) protect and defend the rights or property of Digierack; and/or (c) act under exigent circumstances to protect the personal safety of users of Digierack, or the public.

### Tracking User Behavior

Digierack may keep track of the websites and pages our users visit within Digierack, in order to determine what Digierack services are the most popular. This data is used to deliver customized content and advertising within Digierack to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Digierack. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Digierack website.

### **Use of Cookies**

The Digierack website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
